## Foul Play in the Court room

I would now say Optimism is a comfort to a fool. Not that I think I or any of us as examiners are foolish but when I took on this case a few years ago I thought it was a no-brainer. I followed the methodology I had learned systematically and arrived at my opinion without bias. After careful examination based on my professional opinion, the signature on the will was not signed by him when compared with known signatures. I submitted my report to the attorney with confidence and then we waited for a court date.

When I arrived in court, I thought I had crashed someone's family reunion. Acrylic everywhere, Fake nails, fake hair, eyelashes - wow even fake designer bags!! The waiting area spilled out over into the hallway. Over forty people had come out in support of the other side. My client had three people in her corner. Two women: one her wife and another her aunt.

Day two before I got into the courtroom a fight had broken out between the two parties. Wigs and weaves were lost, and nails broken. So, I had to wait outside with a sheriff beside me until the Judge calmed everyone down. I spent another three hours of abuse and objections and then I looked at the clock thinking we will not go beyond four, so I only must endure this another two hour. And then suddenly the Judge said "This is enough for today!! The judge asked the opposing attorney how much more time do you need. He said at least another two days!! So, we were done for that day.

Between us we decided on a date four months later, which happened to be on the day of my father's anniversary. Still feeling optimistic. There is that word again, 'Optimistic'. I thought I would have more time to prepare although my opinion would remain the same. To my surprise, He requested that I provide the transcripts of the seventeen cases that I had produced on my case history. This was unheard of, and I called several examiners to ask if this was normal. All agreed with me that I should not seek them out or provide them.

The four months went by, I had surgery which took a longer healing process than anticipated and returned to court ready for war. My attorney was still optimistic also her call was brief as I was still on the witness stand, we were not allowed to speak to each other, and we dared not break the rule and she was sure he was watching every move we made. In the meantime, he had time to research all seventeen cases and systematically pulled the four cases that I was not successful with and attempted to read every aspect of each case that was not favorable to my opinion. He asked me what I thought. I could not fight the facts, but that was not the reason I was there to defend my history, so I simply said, "you are a good reader."

So, he continued. Accused me of hiding information by not bringing the transcripts. I told him it was not my job, and that the information of those cases was irrelevant to this case. 

Day Four: When I stepped into the court room there were two sheriffs on either side of me. The proceedings started late as I was later told that my client's car was firebombed the night before. In terms of points, Certified Members should have accumulated at least 20 points, all others 10 points.

Dues are US\$100 except for students/associate members who pay \$50.

Cases lost can sometimes be a treasure chest of lessons to be learned. Or they could be a funny story – in hindsight.




